Training Description

This workshop will explain why and how to think differently about meaningful employment for persons with developmental disabilities. Examples of how to design self-employment that is both meaningful and sustainable will be provided. The presentation will utilize peer-learning, discussion, and activity-based projects with the support of worksheets and media to drive home the training objectives and visualize the outcomes.
